**ORDER**

Plaintiffs' Motion for Summary Judgment is hereby GRANTED, and Franklin County is hereby ORDERED to implement a single member district-based voting system for the primary

1 and general elections for Franklin County Commissioner elections. <sup>The parties</sup> ~~Defendants~~ shall work  
2 cooperatively <sup>together</sup> ~~with Plaintiffs~~ on the development of the district map and seek approval from this  
3 Court on any agreement reached. If the parties cannot agree on a district map, each shall file their  
4 proposal with the Court on or before November 8, 2021. The Court will hold a hearing on  
5 November 15, 2021, at 2:30 am ~~pm~~ when the Court will consider and adopt appropriate  
6 relief, including a district map, in time for implementation before the next county elections.
